The Confederation of Chess for America (CCA) and Brazilian Chess Federation (CBX) are pleased to invite all American chess players to the Panamerican Amateur Chess Championship 2021, categories under 1700, under 2000 and under 2300, to be held in Timbó, Santa Catarina, Brazil, from December, 1st to 5th, 2021

## OBJECTIVES

- 1 DECLARE THE 2021 PANAMERICAN AMATEUR CHESS CHAMPIONS, UNDER 1700 UNDER 2000 AND UNDER 2300;
- 2 QUALIFY THE 2021 PANAMERICAN AMATEUR CHESS CHAMPIONS, UNDER 1700, UNDER 2000 AND UNDER 2300, WITH PERSONAL RIGHT TO WORLD AMATEUR CHESS CHAMPIONSHIP 2022, IN MALTA;
- 3 REWARD THE 2021 PANAMERICAN AMATEUR CHESS CHAMPIONS, UNDER 1700, UNDER 2000 AND UNDER 2300, WITH PERSONAL RIGHT TO PANAMERICAN AMATEUR CHESS CHAMPIONSHIP 2022;
- 4 CONCEDE DIRECT TITLES OF CANDIDATE MASTER (CM-WCM), ACCORDING TO FIDE HANDBOOK;
- 5 CONTRIBUTE TO THE IMPROVEMENT OF TECHNICAL LEVEL OF CHESS IN AMERICA;
- 6 CONGREGATE CHESS COMMUNITY, PROMOTING CULTURAL AND SOCIAL EXCHANGES;
- 7 PROMOTE CULTURAL AND SPORTING TOURISM;
- 8 VALID FOR FIDE RATING

## PLAYERS

The Panamerican Amateur Chess Champions 2021, Under 1700, Under 2000 and Under 2300 are open to all chess players registered with their federation.

In order to participate in the Under 2300 section, a player must not have a published FIDE rating of 2300 or greater for at least one year before the registration deadline. Also, a player must not have any FIDE title above FM (or WFM for women) when the Tournament starts.

In order to participate in the Under 2000 section, a player must not have a published FIDE rating of 2000 or greater for at least one year before the registration deadline. Also, a player must not have any FIDE title above CM (or WCM for women) when the Tournament starts.

In order to participate in the Under 1700 section, a player must not have a published FIDE rating of 1700 or greater for at least one year before the registration deadline. Also, a player must not have any FIDE title above CM (or WCM for women) when the Tournament starts.

## CATEGORIES

## SECTION

## OPEN AND WOMEN

There shall be 3 separate Championships: Under 1700, Under 2000 and Under 2300 rating.

In each section a separate Championship for Women shall be organized if there at least 9 women entries from at least 3 federations. Otherwise, the Championship will be merged with the Absolute Championship of the same category. Trophies and medals will be awarded for merged events as if the events had been separated.



## AWARDS AND TITLES

The first classified of each section and category will be designated "Amateur Pan American Champion", will receive a trophy and will be guaranteed personal right at the 2022 Pan American and 2022 Amateur World Championships (Malta), since the regulatory conditions of FIDE America have been met and as long as its rating remains below 2300 points.

The top three players in their respective categories shall have the personal right to participate the following year. They shall be hosted with free accommodation and meals by the Organizer.

The top three players of each section and category will receive a trophy and will be guaranteed personal right at the Panamerican Amateur Chess Championship 2022, since the regulatory conditions of FIDE America have been met and as long as its rating remains below 2300 points.

The 3 (three) best placed in the categories under 08, 10, 12, 14, 16 and 18, boys and girls, in the under 1700 and under 2000 tournaments will be awarded with medals.

## SYSTEM



Each Championship shall be played over 9 rounds using the Swiss system. However, if there are not enough participants in any category, the Round-Robin system will be used.

## RATE OF PLAY



The rate of play is 90 minutes with 30 seconds increment per move from move 1.

- a) Direct Encounter (code 11);
- b) Number of victories (code 68);
- c) Most black (code 53);
- d) Buchholz cut 1 (code 37);
- e) Buchholz (code 37);
- f) Sonneborn-Berger (code 52).

### Round-Robin

- a) Direct Encounter (code 11);
- b) Number of victories (code 68);
- c) Sonneborn-Berger (code 52);
- d) Koya System (code 45).

If there is still a tie, it'll be by random draw.

## FORFEITS - W.O.



Forfeits will be declared 60 (sixty) minutes after starting the round.

The player who is absent without prior notification will be considered withdrawn, unless they confirm their intention to keep competing before the next pairing is published.

The request for non-pairing must be made in writing to the central arbiter table.

## ELECTRONICS AND COMMUNICATION DEVICES



It is not allowed to carry electronic communication devices in the playing area (e.g. Smartwatch, Tablet, Mobile).

Non-compliance with the measure will be penalized with the loss of the game.

## FEES & ARANCEL CCA - REGISTRATION AND PAYMENT



Players must require the approval of their national federation.

Inform the data (full name, FIDE ID, category, date of birth, individual email, phone / WhatsApp) should only be sent by email to [abertoxadreztimbo@gmail.com](mailto:abertoxadreztimbo@gmail.com).



The total amount of \$ 120 USD can be canceled by means of a bank deposit, assuming the interested party any cost for transfer fees. Both the depositor's data and the justification of the payment must be clearly indicated, and then a copy of the transaction receipt must be sent to the indicated emails.



It is possible to make the payments on arrival, but the values are confirmed with the sending of the flight ticket.

Values include CCA fee (Arancel), registration and credential.

Values for the Blitz Open, \$ 20 USD until 01/11, \$ 30 USD until 26/11.

Late registrations, after 26/11, will be subject to the Organizer's approval and will cost double the value of the entry fees. Entries are personal and non-transferable. No credits or refunds will be made.

## APPEALS



Appeals against decisions of the arbiters or organization must be written, signed and forwarded to [abertoxadreztimbo@gmail.com](mailto:abertoxadreztimbo@gmail.com) by the player (or legal guardian) within 60 (sixty) minutes after the generating factor and/or ending of the game. The appeal must be accompanied by proof of payment of the fee of USD 200. If the appeal is considered relevant, the amount will be refunded. If the appeal is rejected, the amount will be sent to CCA to cover expenses with the Appeals Committee.

## NAVEGANTES AIRPORT TRANSFER
